Old Business:

- 1. Remsburg gave the Ecotone update. He reported 2 projects are in the design stages the Kovalsky Project (Israel Creek) replacing the Thompson Project and the Stevens project (Broad Run). We received invoices from Ecotone for work done on Kolvalsky (\$96,571.20) and Stevens (\$25,970.00). District invoices sent to MDE for design amount plus administrative fees and required documents.
- 2. Remsburg gave the Manure Injection Equipment update 2 invoices have been sent in but are still waiting on payment. Remsburg mentioned he asked Richard Strite if he is interested in purchasing the injector at the end of the grant, he said not. D. Dotterer is inquiring with someone on the Eastern Shore about potential interest.
- 3. Remsburg and Rakestraw reported on the Winter MASCD Meeting.
 - A. BMP verification shows 75& of practices met standards. Remaing 25% is a combination of Does not exist, Does not meet standards, No animals present. We can bring some back into compliance by repairing damaged practices.
 - B. Bay quality received a C grade at this point but on track to meet goals by 2025.
 - C. They want to change the noxious weed penalty from criminal offense to civil offense.
 - D. There was talk of possibly using Cover Crop grain for breweries; nothing is planned at this time.
 - E. Met with Legislators at the luncheon on Thursday to discuss items of interest.
- 4. Remsburg reported the new Equipment Committee met, they tossed around some ideas but no decisions were made. Remsburg is going to make contact with other Districts to get more information.
- 5. Remsburg gave the update on the 75th Anniversary; he presented 2 logos for the Board to choose from. Information was sent around for the Board to decide on handouts. The question was asked as to getting a key note speaker, no decisions were made at this time.
