- 2. Remsburg gave the Manure Injection Equipment update: Injection has been done for G. Grossnickle and D. Doody. Deer Spring being low priority acres. Adam Wivell needs to be done yet, since his pit will not hold until March 1°. An invoice from Allegheny Ag in the amount of \$1050 dollars for injection done on the Isaac Martin Farm in Washington County.
