- 1. Remsburg gave the Ecotone update, he submitted the Monthly Report to DNR and an invoice for the amount of \$176,376 dollars to complete the project. The As-built still needs to be done. DNR wants to see the project. Ecotone is looking for new possible projects.
- 2. Remsburg gave the updated Manure Injection Equipment Report. The Injector portion was delivered this week, the Tanker is being transported after the first of the year. The buyer wired the payment to Allegheny Ag. Remsburg is going to pick up the check tomorrow and deliver the \$2500 dollars check to Richard Strite for advertisement, sales and lining up the trucking. Keith Wiles is not interested in the Frac Tank, he suggested contacting Miss Trucking. Remsburg called but has not heard back.
- 3. Remsburg gave the Cover Crop update: All reporting has been completed. Two fall certifications still need to be submitted with seed tags. There was 158 Fall Certifications submitted for a total of 30,781 acres and a Fall payment request of \$505,000 dollars.
- 4. Remsburg gave the Park and Ride update. The Option Contract has been signed by both Boards and delivered to SHA. Remsburg said SHA is willing to work with SCD and General Services about repayment of the Grant.
- 5. Remsburg reported the Pilot Buffer Program is posted on their website. Remsburg is going to post on SCD's website and Facebook. The program is to be Funding through Chesapeake Bay Trust and starts taking applications in January.
