## Old Business:

- 1. Remsburg gave the Ecotone update, final payment has been received from DNR in the amount of \$176,736.73 dollars to make the last payment to Ecotone. The As-built plan has been received. DNR wants to look at the finished project. No new projects are being looked at, at this time.
- 2. Remsburg gave the Manure Injection update: The Tank portion has been shipped on January 18<sup>th</sup>. The Frac tank has not been sold at this time. A call was returned from David Miss and he is not interested in the Frac Tank. There was a Motion: Myers/Troxell to close out the SAM Account and transfer the funds to the CDARS Account. All in agreement.
- 3. Remsburg gave the Park & Ride update: It is in the hands of SHA at this time, the contract needed to go to higher authority level for approval since it was more than the original contract. There is not a problem since the final contract was agreed to. Mr. Lambert asked how to disperse the check and is working with the Districts to see if any portion of the grant needs to be paid back to Department of General Services.
- 4. Remsburg reported the Buffer Pilot Program is taking applications at this time through the first part of February. It is posted on the MDA Website on SCD's Website and Facebook.
- 5. Remsburg reported the MASCD Winter Meeting will be held on February 1\* at 9:30am. This will be a Virtual Meeting; the agenda was sent out with the Board Meeting Packet. There was a Motion: Hipkins/Troxell to approve for the Associates to attend if they would like. All in agreement.
