## **OLD BUSINESS:**

- 1. Hutchinson gave the Park and Ride update, T. Salisbury was not able to access the SHA plat online, he said the Boards would need to hire an Attorney to get a confirmatory Deed. The Board decided to first try to meet a State Highway Representative on site to see if the corners have pins. Hutchinson also reported at this time she has not received an email or letter stating any changes on repayment on the grant.
- Hutchinson reported that she, Grossnickle and Falkenstein met with Katie Stevens regarding the potential of selling Ag. ground to the County. Stevens said she is starting to do a feasibility study on the first phase of the project which she has a year to complete. Hutchinson said at the same time she received a phone call from Johnathon Purtz with Victory Baptist Church inquiring about the purchase of the Ag. ground.

- 3. Hutchinson reported the Districts had a tele-conference with MDE on small pond approval, there is still a lot of unanswered questions. The Board decided to take no action at this time.
