What a busy and exciting year 2022 was! I marked my first anniversary as District Manager, we are at full staff in both the urban and agricultur- relevant topics. We welcome your al programs and we participated in several outreach activities to engage the public about the conservation efforts of Frederick County Farmers.

The districts hosted a booth at the Great Frederick Fair and participated Heather Hutchinson in Harvest Days at the Sabillasville Environmental School. Each event involved hands-on activities where students learned about the importance of soil health.

We partnered with the Frederick County Farm Bureau and Horizon Farm Credit to host the Soil Smart Farm Tour in September. # **COVER CROP**

#### Preparing for your 2023-2024 Cover Crop Application

Annual Cover Crop sign-up will be here before you know it. To be eligible for participation, you must be in good standing with the Conservation Grants Program and have a current Nutrient Management Plan.

The nutrient management consultant position at Frederick Extension is currently vacant so it is more important than ever to start this process early! If your plan has been written by Extension in the past, please contact the extension office. Extension is working the Maryland Department of Agriculture (MDA) to assign plans for Frederick County farmers to other county extension offices and MDA employees. Priority is being given to those farmers who plan to participate in cost share programs like Cover Crop.

# **MANURE TRANSPORT**

#### **PROGRAM**

The Manure Transport Program helps cover the cost of injecting manure and/or transporting manure to farms with low phosphorus fields. To qualify for transport assistance, manure must be transported more than 1 mile from the sending source. There is no distance requirement for manure injection. As with all cost share programs, you must have a current nutrient management plan.

Manure can be applied after March 1st with the last day to haul of December 15th.

- For Spring or Summer land application—manure must be transported or injected by September 9th.
- For Fall land application—manure must be transported or injected by December 15th.
- The claim for cost-share funds must be submitted to MDA within 30 days of the relevant September or December deadline.

# **CONSERVATION AG LEASE BUILDER**

Recently the University of Maryland's Agricultural Law Education Initiative launched an online ag lease builder to help farmers and landowners create agricultural leases. This tool is FREE and intended to protect business interests, encourage environmental stewardship, and support implemented conservation practices on leased land. The lease builder asks for information on the property, landowner, tenant, length of lease, etc. After building the draft lease, parties are encouraged to seek individual legal advice prior to execution. ## THE RIPLEY FAMILY

The Ripley Family of Ripleyvale Farms were selected as the Frederick SCD Cooperator of the year. The Ripleys raise replacement dairy heifers and grain crops on over 400 acres. They have worked with the Soil Conservation District for many years and with their most recent projects, have addressed all of the identified resource concerns on their farm. In 2022 they installed a waterway, roofed heavy use area and manure storage. All of their streams are fenced and they are converting crop ground to pasture with the goal of retiring marginal pastures. The Ripleys prioritize conservation and have instilled this value in their children and now grandchildren. Their conservation efforts provide benefits beyond the farm gates and are worthy of celebration.









#### THE DERR FAMILY

Over the past 10 years, Chris and Jamie Derr, of Valley Ho
Farm, have implemented many conservation practices to
protect and preserve the natural resources of their dairy farm.
Fencing, a watering trough and a roofed heavy use area protect
a stream and increase options and opportunities to maximize
grazing while maintaining healthy, productive pastures on the
farm. They plant cover crops protect the soil over the winter
months. Liquid and solid manure storage facilities help the
farm to effectively manage manure nutrients to the benefit of
crops and the environment. The Derr's commitment to
conservation serves not only the farm, but the Middletown
Valley, Catoctin watershed, and all of their downstream
neighbors.

# DIGGING DEEPER INTO SOIL HEALTH

A day full of learning, innovative ideas, and fellowship.

On February 7th our Districts, in cooperation with Frederick County Farm Bureau and the Maryland Association of Soil Conservation Districts, held "Digging Deeper into Soil Health" at the Great Frederick Fair Grounds Null Building. Our keynote speaker was Jim Hoorman of Hoorman Health Services. Mr. Hoorman is currently a private industry consultant on soil health who has been a National No-Till Convention Speaker, was a former national Soil Health Specialist with NRCS, and also was a former Ohio State University Extension Agent.

The days talk was tailored to Maryland soils, climate, and agricultural practices. Topics included slugs, the nitty gritty of soil structure and composition, micronutrients and humates for plant health, and the importance of soil ecology and nutrient cycling. Local ag sales companies along with government agencies were set up and able to answer questions as well. We look forward to hosting another event like this in the future!
